

**FOLLOW-UP NOTICE TO ALL MORTGAGE BANKING LICENSEES**  
**REGARDING ANNUAL FINANCIAL STATEMENTS**

All licensees must submit their annual financial statements either to the Division of Banking or to the NMLS within 90 days of their stated fiscal year end. Licensees who fail to submit timely financial statements will be assessed a late fee of \$50.00 per calendar day, for up to three months, unless extended in writing for cause by the Director, per Section 38 Illinois Administrative Code 1050.430.
