SPRINGFIELD, IL - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Director of the Division of Professional Regulation, Daniel E. Bluthardt, signed the following disciplinary actions taken during the month of **March 2007**.

ACCOUNTANT

Taylor, Rees, Beckey & Company, Rock Island - public accounting professional service corporation license (060-004999) reprimanded for temporarily suspending a municipal audit due to a dispute with city officials, addressing the city council regarding this matter, and then after being terminated, issuing an "Independent Auditors Report" which included references to the city officials in the dispute.

John William Funk, Chicago – public accountant license (065-014180) reprimanded and fined \$3,750 for performing five annual audits for a not for profit corporation with a non-renewed license.

Ronald A. Safran, Darien, CT – public accountant license (065-019191) suspended for a period to run concurrently with and due to a suspension of the right to practice before the US Securities and Exchange Commission

ARCHITECTS, LAND SURVEYORS, PROFESSIONAL ENGINEERS AND STRUCTURAL ENGINEERS

Robert A. Arron, Arlington Heights – (unlicensed) ordered to cease and desist the unlicensed practice as a professional engineer and ordered to pay a civil penalty of \$1,000.
