REAL ESTATE EDUCATION ADVISORY COUNCIL BUSINESS MEETING July 19, 2007 MINUTES

The Real Estate Education Advisory Council (EAC) convened at 9:30 a.m. on July 19, 2007 at 500 E. Monroe, Springfield, Illinois for the purpose of conducting a general business meeting.

APPROVAL OF MINUTES:

Motion: A motion was made/seconded to approve the June 14, 2007 Real Estate Education Advisory Council Minutes. Motion passed unanimously.

AGENCY UPDATE:

Mr. Oaks reported that 71 pre-license schools have renewed; 5 schools have submitted their renewal application but are deficient; at least 3 schools are not renewing; and 10 schools have not responded.

Effective July 1, 2007, Mary Anne Benden is no longer the Director of Enforcement because her contract was not renewed. The Division appointed Eileen Lewalski to be Acting Chief of Prosecution on July

2nd; she has subsequently given a 3 week notice that she is leaving the agency. The positive situation is that the Agency has 2 law students and 1 summer intern that are very productive in addressing prosecution cases.

Mr. Hardgrove mentioned that the salesperson's licenses are down from the last renewal with only approximately 50,000 being renewed as of June 30, 2007; the number of individuals taking pre-licensing courses is down. Council discussed the past, current and the upcoming year potential in the real estate market.

Mr. Edwards mentioned that every Realtor Association had at least one broker management course completed or one was being scheduled.

REEF reported that of have been 300 to 400 brokers completing the broker management test, 3 failed. Council discussed the issue on brokers that fail the exam have the opportunity to keep taking the course until they pass; if brokers do not pass the exam by the time they renew their license the effect will then take place. The third "Training the Instructor" seminar for the Broker Management course will be held on Tuesday, July 31, 2007 at the Oakbrook Double Tree.
