AGENCY UPDATE:

Eleni Markos, the new real estate investigator, started on October 16, 2008; the Division now has 4 investigators (3 in Chicago and 1 in Springfield). The Division has utilized the Examiners for the past 5 months to assist in investigations on a full time basis. Investigations has categorized all cases as 1,2 3, 4 to identify technical to severe violations.

OLD BUSINESS:

AMP will start presenting the simulation test on February 9, 2009; the last multiple choice test is scheduled for January 31, 2009.

The Broker Management Course Part II is still being worked on.

NEW BUSINESS:

There will be meeting on November 14th at DPR in Springfield to discuss the Real Estate License Law rewrite. Mr. Hardgrove asked the attendees their thoughts on any items needing to be addressed. A few attendees gave their suggestions which were: definition of a proctor, eliminating language in the Act that does not apply to today's standard, also offices, website advertising and "transaction agency" were discussed by the Council.

The attendees also mentioned that they would like the Division to have somebody review the website to determine why some of the licensee's continuing education isn't properly reflecting their completion of CE Courses. Mr. Fair asked how many brokers are going to receive a non-compliance letter on not completing the broker management course when they did; Mr. Brockhouse mentioned that there is a problem with the system which should be resolved shortly.
