CONSUMER CREDIT

Americash Loans, LLC, Chicago – PLRA license (1372) fined \$77,350 for the following violations: licensee does not keep a separate, complete file for each obligor, file did not contain a promissory note in the file, evidence of a signed or acknowledged Truth-In-Lending Disclosure is not in the file of original papers, file does not contain evidence of a Wage Assignment signed by the wage earner, and file does not contain evidence of a contract signed or acknowledged by the borrower.

Americash Loans, LLC, Chicago – CILA license (2063) fined \$69,150 for the following violations: the annual percentage rate is not accurately disclosed, licensee does not keep a separate, complete file for each obligor, file did not contain a promissory note in the file, judgment obtained for incorrect amount or included additional fees not allowed, files did not contain the security agreement, and file does not contain evidence of a contract signed or acknowledged by the borrower.

America's Financial Choice, Inc., Oak Park – PLRA license (1279) fined \$21,400 for the following violations: original documents, or approved equivalent, not cancelled or returned following payoff, lender did not verify that the loan was permissible, lender did not enter into the database that the borrower's loan was paid in full or cancelled on the day the transaction was made, lender did not have a ready supply of the Illinois guide to Payday Loans pamphlets to provide borrowers, lender charged more than \$15.50 per \$100 loaned on a payday loan, lender did not properly enter loan(s) into the database on the day made, a partial payment on a PLRA loan or repayment plan was not entered into the database on the date the transaction was made, and official income documentation was not the required type for a payday loan or was not for income for the 30 days preceding the loan.

America's Financial Choice, Inc., Chicago – CILA license (1717) fined \$14,700 for the following violations: the annual percentage rate is not accurately disclosed and security is not properly disclosed.

Devon Financial Services, Inc. Chicago – CILA license (3411) fined \$11,650 for the following violations: licensee did not operate under licensed name, improper simple interest calculation, licensee's or retail seller's name and address is not properly disclosed on legal document, and the loan contract does not accurately disclose the schedule of payments or the total of payments.

The Payday Loan Store of Illinois, Inc., Melrose Park – CILA license (2182) fined \$8,150 for the following violations: the annual percentage rate is not accurately disclosed and improper simple interest calculations.

America's Financial Choice, Inc., Calumet City – PLRA license (1284) fined \$7,750 for the following violations: lender did not verify the loan was permissible, lender did not enter into the database that the borrower's loan was paid in full or cancelled on the day the transaction was made, and lender charged more than \$15.50 per \$100 loaned on a payday loan.

America's Financial Choice, Inc., Chicago – PLRA license (1281) fined \$6,775 for the following violations: security is not properly disclosed, original documents, or approved equivalent, not cancelled or returned following payoff, and lender did not enter into the database that the borrower's loan was paid in full or cancelled on the day the transaction was made.

Devon Financial Services, Inc., Chicago – PLRA license (1609) fined \$6,150 for the following violations: licensee not operating under licensed name, licensee's or retail seller's name and address is not properly disclosed on legal document, and lender did not verify the loan was permissible.

Citizens Finance Company, d/b/a Citizens Finance of Illinois, Loves Park – CILA license (1827) fined \$5,700 for failure to properly disclose security.

The Payday Loan Store of Illinois, Inc., Chicago – CILA license (1531) fined \$5,250 for the following violations: improper simple interest calculations, licensee did not send borrower a Notice of the Right to Redeem with all required information, licensee did not deliver or mail to the borrower an affidavit of defense, date of repossession not available in the account record, licensee did not give written notice of intended sale/disposition of repossessed collateral including all required information, payment history of the repossession account does not properly identify the proceeds from the sale of collateral, repossession file does not contain signed receipts showing the collateral purchased, the amount paid and the name of the obligor, repossession file does not indicate a statement of final accounting containing the required information was sent to the borrower, repossession file does not contain a copy of the condition of collateral at time of repossession, the licensee did not have receipts to document charges in connection with the sale of collateral, and file does not contain evidence of a contract signed or acknowledged by the borrower.

QC Financial Services, Inc., d/b/a National Quik Cash, Chicago – PLRA license (1256) fined \$5,200 for the following violations: lender did not verify that the loan was permissible, lender did not enter into the database that the borrower's loan was paid in full or cancelled on the day the transaction was made, and lender did not properly enter loan(s) into the database on the day made.

Citizens Finance Company, d/b/a Citizens Finance of Illinois, Crystal Lake – CILA license (2895) fined \$4,950 for failure to properly disclose security.

QC Financial Services, Inc., d/b/a National Quik Cash, Chicago – PLRA license (1270) fined \$4,000 for the following violations: lender did not obtain any official documentation of the borrower's income before making a payday loan, loans over 25% of borrower's income, and lender made a payday loan resulting in the borrower having a combined outstanding payday loan principal balances greater than 25% of borrower's gross monthly income.

The Payday Loan Store of Illinois, Inc., Country Club Hills – CILA license (1698) fined \$4,000 for the following violations: the annual percentage rate is not accurately disclosed, improper simple interest calculations, security is not properly disclosed, evidence of a signed or acknowledged Truth-In Lending Disclosure is not in the file of original papers, and repossession file does not indicate a statement of final accounting containing the required information was sent to the borrower.

Advance America, Cash Advance Centers of IL, Inc., d/b/a Advance America, Cash Adv. Ctrs., Alton – CILA license (1658) fined \$3,775 for the following violations: the first installment period exceeds one month by more than fifteen days and the repayment receipt does not accurately show the required elements.

The Payday Loan Store of Illinois, Inc., Lyons – CILA license (1697) fined \$3,650 for the following violations: improper simple interest calculations and repossession file does not indicate a statement of final accounting containing the required information was sent to the borrower.

Cash To Go at Wheeling, Palatine – CILA license (2959) fined \$3,525 for the following violations: security is not properly disclosed, lender does not have possession of the original title registered to the borrower(s) on the short term loan, and security is not released.

America's Financial Choice, Inc., Oak Park – CILA license (1273) fined \$2,700 for the following violations: improper simple interest calculations and security is not properly disclosed.

Illinois Title Loans, Inc., Calumet City – PLRA license (1440) fined \$2,500 for the following violations: lender did not enter into the database that the borrower's loan was paid in full or cancelled on the day the transaction was made, lender did not obtain any official documentation of the borrower's income before making a payday loan, loans over 25% of borrower's income, and lender made a payday loan resulting in the borrower having a combined outstanding payday loan principal balances greater than 25% of borrower's gross monthly income.

B&B Investment Group, d/b/a Cash Loans Now, Moline – CILA license (2723) fined \$2,400 for the following violations: licensee did not maintain a positive net worth of a minimum of \$30,000, the loan document or other legal instrument contains blanks, and licensee did not provide requested documents or information during the exam.

Heights Finance Corporation, Kankakee – CILA license (1998) fined \$2,400 for the following violations: the loan document or other legal instrument contains blanks, security is not properly disclosed, and evidence of a signed or acknowledged Truth-In Lending Disclosure is no in the file of original papers.

Midwest Title Loans, Inc., Grayville – CILA license (3297) fined \$2,075 for the following violations: licensed location did not prominently display the hours of operation, licensed location did not prominently display the license or renewal certificate, the licensed location does not maintain a complete permanent file, and licensee did not maintain a positive net worth of \$30,000.

Cottonwood Financial Illinois, LLC d/b/a The Cash Store, Marion – PLRA license (1575) fined \$2,050 for the following violations: original documents, or approved equivalent, not cancelled or returned following payoff, lender did not obtain any official documentation of the borrower's income before making a payday loan, and official income documentation was not the required type for a payday loan or was not for income for the 30 days preceding the loan.

Check Into Cash of Illinois, LLC, d/b/a Check Into Cash, Chicago – PLRA license (1231) fined \$1,750 for failure to enter into the database that the borrower's loan was paid in full or cancelled on the day the transaction was made.

The Payday Loan Store of Illinois, Inc., Joliet – CILA license (2183) fined \$1,550 for the following violations: improper simple interest calculation, evidence of a signed or acknowledged Truth-In Lending Disclosure is not in the file or original papers, evidence of a Truth-In Lending Disclosure is not in the file of original papers, licensee did not properly post the sale of collateral or proceeds to the account record, payment history of the repossession account does not properly identify the proceeds from the sale of collateral, repossession file does not contain signed receipts showing the collateral purchased, the amount paid and the name of the obligor, repossession file does not indicate a statement of final accounting containing the required information was sent to the borrower, repossession file does not contain a copy of the condition of collateral at time of repossession, the licensee did not have receipts to document charges in connection with sale of collateral, and licensee failed to properly document the disposition date of collateral.

American General Financial Services of Illinois, Inc., Hanover Park – CILA license (611) fined \$1,450 for the following violations: the loan document or other legal instrument contains blanks, licensee did not dispose of repossessed collateral in a commercially reasonable manner, repossession file does not contain signed receipts showing the collateral purchased, the amount paid and the name of the obligor, repossession file does not indicate a statement of final accounting containing the required information was sent to the borrower, repossession file does not contain a copy of the condition of collateral at time of repossession, and file does not contain evidence of a contract signed or acknowledged by borrower.

Midwest Title Loans, Inc., Summit – CILA license (1843) fined \$1,350 for the following violations: licensee did not send borrower a notice of the Right to Redeem with all the required information, licensee did not give written notice of right to recover to buyer within 3 days of repossession of collateral, licensee did not deliver or mail to the borrower an affidavit of defense, licensee did not give written notice of intended sale/disposition of reposed collateral including all required information, repossession file does not contain signed receipts showing the collateral purchased, the amount paid and the name of the obligor, repossession file does not indicate a statement of final accounting containing the required information was sent to the borrower, and repossession file does not contain a copy of the condition of collateral at time of repossession.

Get It Now, LLC, d/b/a Home Choice, Rockford – SFA license (1240) fined \$1,350 for the following violations: licensee moved without 10 day notice or the applicable preapproval from the Director, the annual percentage rate is not accurately disclosed, and amendment to closed-end contract or retail contract was not signed by obligor and lender.

One Iron Ventures, Inc., d/b/a First Cash Advance, Chicago – PLRA license (1292) fined \$1,150 for the following violations: loans over 25% of borrower's income, Lender made a payday loan resulting in the borrower having combined outstanding payday loan principal balance greater than 25% of borrower's gross monthly income, and wage assignment was accepted from borrower that contained blank spaces.

Honor Finance Corporation, Evanston – SFA license (1021) fined \$1,000 for the following violations: improper simple interest calculation and repossession file does not contain a copy of the condition of collateral at time of repossession.

Cashland Financial Services, Inc., Danville – PLRA license (1548) fined \$1,000 for making a payday loan resulting in the borrower having a combined outstanding payday loan principal balance greater than 25% of borrower's gross monthly income.

The Payday Loan Store of Illinois, Inc., Lombard – CILA license (2887) fined \$1,000 for the following violations: repossession file does not contain signed receipts showing the collateral purchased, the amount paid and the name of the obligor and repossession file does not indicate a statement of final accounting containing the required information was sent to the borrower.
