Division of Banking

BANKS AND TRUSTS

American Enterprise Bank, Buffalo Grove – consent order to stop engaging in unsafe and unsound banking practices.

Community First Bank – Chicago, Chicago – consent order to stop engaging in unsafe and unsound banking practices.

Equity Loans, LLC, Atlanta, Georgia – ordered to cease and desist using bank’s name without permission.

Flagship Mortgage Corporation, Elmhurst – ordered to cease and desist using bank’s name without permission.

New Century Bank, Chicago – consent order to stop engaging in unsafe and unsound banking practices.

PAWNSHOPS

Delgado Jewelry, Joliet – ordered to cease and desist and levied a \$765 civil penalty for practicing as a pawnshop without a license.

More Money Gold & Pawn, Salem – levied a \$1,000 civil penalty for disposing of deposited property.

CONSUMER CREDIT SECTION

CAR Financial Services, Inc., 10770 Wateridge Circle, Suite 250, San Diego, CA – SF License (1273) fined \$3,550 for the following violations: The annual percentage rate was not accurately disclosed, improper simple interest calculations, the loan contract did not accurately disclose the schedule of payments of the total of payments, licensee did not dispose of collateral within 90 days of repossession, repossession file did not indicate a statement of final accounting containing the required information was sent to the borrower, and licensee purchased sales finance contracts from seller using a contract, security instrument, or other document not in conformance with the provisions of the Retail Installment/ Motor Vehicle Retail Installment Sales Act or other State/Fed statutes.

Cottonwood Financial Illinois, LLC, 1701 North Larkin Street, Suite 901, Crest Hill – CILA License (3365) fined \$4,225 for the following violations: Improper simple interest calculations, the payment receipt did not accurately show the required elements, make, model, year, and VIN of automobile were not on the title-secured loan document, lender made a title-secured loan with a scheduled monthly payment exceeding 50% of the obligor's gross monthly income, lender did not input accurate information into the database to determine if the obligor was eligible for a loan, and lender did not obtain any official documentation of the borrower's income before making a payday or title-secured loan.

National Credit Lenders, LLC, 157 West 159th Avenue, Harvey – CILA License (3467) fined \$1,025 for the following violations: Licensed location was not maintaining posted hours, licensed location did not prominently display the license or renewal certificate, the annual percentage rate was not accurately disclosed, file did not contain promissory note in the file, evidence of a signed or acknowledged Truth-In-Lending Disclosure was not in the file of original papers, the loan contract did not accurately disclose the schedule of payments or the total of payments, and licensee did not provide requested documents or information during the exam.

S&H Quick Cash Loans, 249 E. Indian Trail Road, Aurora - CILA License (3458) fined \$6,550 for the following violations: The annual percentage rate was not accurately disclosed, improper simple interest calculations, the loan contract did not accurately disclose the schedule of payments or the total of payments, and security was not released.

The Payday Loan Store of Illinois, Inc., 3175 West 175th Street, Suite B, Hazel Crest – CILA License (3459) fined \$10,000 for the following violations: Improper simple interest calculations, the payment receipt did not accurately show the required elements, the title-secured loan agreement did not prominently disclose DFI's address and phone number and advise the borrower of the right to report lending and collection violations, title-secured lender did not obtain borrower's most recent income documentation available at the time the loan was made, and lender did not obtain any official documentation of the borrower's income before making a payday or title-secured loan.

Tri-State Financial Services, Inc., 15898 South LaGrange Road, Orland Park – CILA License (3463) fined \$4,000 for the following violations: Licensee did not maintain a positive net worth of a minimum of \$30,000, the title-secured loan agreement did not prominently disclose DFI's address and phone number and advise the borrower of the right to report lending and collection violations, title-secured lender did not obtain borrower's most recent income documentation available at the time the loan was made, and lender did not input accurate information into the database to determine if the obligor was eligible for a loan.

Tri-State Financial Services, Inc., 1187 North Farnsworth Avenue, Suite 103, Aurora – CILA License (3462) fined \$9,100 for the following violations: The licensed location did not maintain a file of original papers, the title-secured loan agreement did not contain a separate statement signed by the borrower that he/she has not had an outstanding title-secured loan in the last 15 days, the title-secured loan agreement did not prominently disclose DFI's address and phone number and advise the borrower of the right to report lending and collection violations, lender made a title-secured loan with a scheduled monthly payment exceeding 50% of the obligor's gross monthly income, lender did not input accurate information into the database to determine if the obligor was eligible for a loan, and lender did not obtain any official documentation of the borrower's income before making a payday or title-secured loan.
