**SPRINGFIELD** - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Acting Director of Professional Regulation, Donald W. Seasock; and the Directors of Financial Institutions, Robert Meza; and Banking, Jorge A. Solis signed the following disciplinary orders in the month of **September 2010**.

**America United Bank and Trust Company USA, Schaumburg** – consent order to stop engaging in unsafe and unsound banking practices.

**Farmers State Bank of Sublette, Sublette** – consent order to stop engaging in unsafe and unsound banking practices.

**Premier Bank, Wilmette** – consent order to stop engaging in unsafe and unsound banking practices.
