SPRINGFIELD, IL - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Director of the Division of Professional Regulation, Daniel E. Bluthardt, signed the following disciplinary actions taken during the month of **December 2007**.

ACUPUNCTURE

Dong Lae Suh, Wheeling – (unlicensed) ordered to cease and desist the unlicensed practice as an acupuncturist and to pay a civil penalty of \$500 within 60 days

BARBER, COSMETOLOGY, ESTHETICS AND NAIL TECHNOLOGY

Regina Ann Childress, Gary, IN – cosmetologist license (011-263295) placed on indefinite probation after defaulting on an Illinois educational loan and has now entered into a repayment agreement.

Donna L. Johnson, Chicago – cosmetologist license (011-266956) placed on indefinite probation after defaulted on an Illinois educational loan and has now entered into a repayment agreement.

Jennifer S. Mahar, Champaign – cosmetologist license (011-266800) placed on indefinite probation for a minimum of five years due to felony convictions.

Sylester Miles, Chicago – cosmetologist license (011-229827) indefinitely suspended and ordered to pay a \$500 civil penalty due to unlicensed practice.

Maria G. Negrete, Naperville – cosmetologist license (011-190712) revoked for being more than thirty days delinquent in the payment of child support.

Amadella a/k/a Amadelia a/k/a Irene Ramirez Marquez a/k/a Calvillo, Elk Grove Village – cosmetologist license (011-267194) revoked based on material misstatement, obtaining a license by fraud or misrepresentation, and practicing cosmetology by fraudulent means.

Bobby L. Rogers, Chicago – barber license (006-062503) placed on indefinite probation for a minimum of three years and fined \$1,000 due to misrepresentation of information on licensure application.

Patty Carter, Chicago – nail technician license (169-006237) indefinitely suspended for a minimum of six months and fined \$750 due to a felony conviction, material misstatement, misrepresentation and unprofessional conduct.

Chicago Nail School, Calumet Park – nail technician school license (171-000106) placed on indefinite probation for a minimum of three years \$1,000 fine for repeated violations of the Barber, Cosmetology, Esthetics and Nail Technology Act based on teacher briefly practicing on a non-renewed license as well as failure to notify students of class cancellations.

DENTAL

Debora Suzan Klein, North Barrington – dental license (019-017793) ordered to pay a fine of \$1,000 and to complete six hours of continuing education in pharmacology for prescribing antibiotics outside the scope of dentistry.

Kenneth Lutsch, Machesney Park – dental license (019-20868) and controlled substance license (319-010146) placed on 90 day suspension effective retroactive to 09/25/07 and immediately followed by indefinite probation for a minimum of three years with work restrictions after failure to maintain proper controlled substance records; performed treatment outside the scope of dentistry and the misuse of nitrous oxide.

Randall Raabe, Crystal Lake – dental license (019-16792) placed on indefinite probation for a minimum of two years for the misuse of nitrous oxide.

Gerardo Gonzalez, Chicago – (unlicensed) ordered to cease and desist the unlicensed practice of dentistry and to pay a civil penalty in the amount of \$10,000.
