**ORDER REVOKING**  
**LOAN ORIGINATOR REGISTRATION**

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking, (the "Department"), having conducted an examination of the facts related to registered Loan Originator Kelli R. Wilson, (the "Registrant"), 8127 Shadow Creek Lane, Yorkville, Illinois 60560 and having documented violations of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635] and the rules promulgated under the Act (the "Rules") [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 7-1 of the Act and Section 1050.2170 of the Rules. The Department makes the following:

**FINDINGS**

1. That Registrant is an Illinois Loan Originator Registrant holding certificate of registration No. 031.0011541 and having the address of 8127 Shadow Creek Lane, Yorkville, Illinois 60560;
2. That Registrant is also owner of the Illinois residential mortgage licensee Investor's Choice Mortgage Corporation (License No. MB.6760072);
3. That Registrant performed loan originator services commencing on or around July 3, 2007 in regards to assisting a buyer in purchasing a residential investment property located at 1100 Norwood Lane, Aurora, Illinois 60504 (the "Property");
4. That since buyer, as an investor, was not qualified for a loan under the Lender's no document program, Registrant falsified the application to state that the Property was to be owner-occupied, rather than an investment property;
5. That Registrant had buyer falsely use one of Registrant's rental property addresses at 3940 Paradise Canyon Ct, Naperville, Illinois 60564 as her present address with a notation "living rent free" instead of her true present address 16215 Fairfield Dr., Plainfield, Illinois 60564 for the purpose of improving the likelihood of the Lender's approval of the loan application;

6. That Registrant submitted the loan application and file with said fraudulent information to the Lender and a subsequent lender ultimately achieving approval of said loan application to Registrant's benefit of fees and other gains and lender's detriment in approving an otherwise non-approvable loan; and
7. That the Department opened an investigation into Registrant's loan originator activities and Registrant verified to the Department the findings contained herein.

**CONCLUSIONS**

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

Registrant's activities under Certificate of Registration No. 031.0011541 cited herein warrant revocation of said registration pursuant to Rules Sections 2165(b) (c) and (e).


**ORDER**
