

## Pending Applications for Registration of a Title Insurance Agent

The following spreadsheet shows the current status of Applications received and logged in by the end of the preceding week. The spreadsheet is updated each Monday, so it is not a “real time” report for the current week. Applications are shown by name of agent, in the order received and logged in with the name of registering title insurance company.

If an Application has been returned to the registering title insurance company for correction, the return date is shown. Thereafter, if that Application is resubmitted, the date the resubmission was received is shown. An Application shown as “Approved” indicates that the letter and Certificate of Registration have been mailed to the registered title insurance agent, with copies to the registering title insurance company. If such letters and Certificates are not received within two weeks following the date of Approval, please contact the Title Insurance Section.

Calls and emails with questions about the status of an Application for Registration simply reduce productivity, so please confine inquiries to use of the spreadsheet below, which will be updated weekly.
