Springfield, Illinois – Leonard A. Sherman, Director of the Illinois Department of Professional Regulation, announced the following disciplinary actions taken by the Department during the month of **March 2001**.

ARCHITECTURE

Alexander Bernhardt, Chicago – architect license (001-014185) reprimanded and fined \$1,000 for practicing on a non-renewed license.

Michael Leary, Chicago – architect license (001-009826) reprimanded and fined \$1,500 for practicing on a non-renewed license.

Marcus Stokes, Chicago – ordered to pay a civil penalty of \$3,000 for the unlicensed practice of architecture.

BARBER
