SPRINGFIELD, IL – Fernando E. Grillo, Secretary of the Illinois Department of Financial and Professional Regulation (IDFPR), announced the following disciplinary actions taken by the Division of Professional Regulation during the month of **October 2004**.

BARBER, COSMETOLOGY, ESTHETICS AND NAIL TECHNOLOGY

Kimberly K. Brummitt, Washington – cosmetologist license (011-221996) placed in refuse to renew status for being more than 30 days delinquent in the payment of child support.
