ACCOUNTANT

Mark Douglas Kirstein, Naperville – public accountant license (065-026346) suspended concurrent with US Securities and Exchange suspension.

ARCHITECTS, LAND SURVEYORS, PROFESSIONAL ENGINEERS AND STRUCTURAL ENGINEERS

Robert A. Arron, Arlington Heights – ordered to cease and desist the unlicensed practice of professional engineering.

MEDICAL

OPTOMETRY

PSYCHOLOGY

Ravenswood Medical Resources Corp., Chicago – wholesale drug distributor license (04-001223) indefinitely suspended and fined \$70,000 for failure to provide complete updated information to IDFP within 45 days from the date of change and practiced as an unlicensed wholesale drug distributor.
