SPRINGFIELD, IL - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Director of the Division of Professional Regulation, Daniel E. Bluthardt, signed the following disciplinary actions taken during the month of **May 2006**.

BARBER, COSMETOLOGY, ESTHETICS AND NAIL TECHNOLOGY

Gina M. Heffron, Bartlett – cosmetologist license (011-198620) suspended for 30 days followed by indefinite probation after submitting a false application stating she had successfully completed continuing education requirements.

Tracey Jones, Chicago – unlicensed, ordered to cease and desist the unlicensed practice of cosmetology and barbering.
