SPRINGFIELD, IL - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Director of the Division of Professional Regulation, Daniel E. Bluthardt, signed the following disciplinary actions taken during the month of **September 2006**.

ACCOUNTANT

Christopher Emerle, Skokie - public accountant license (065-012848) indefinitely suspended for failure to respond to Department inquiry and failure to respond to client's successor accountant inquiry.

Donald J. Todd, Calumet City - public accountant license (065-008534) indefinitely suspended due to a federal criminal conviction for violations of the Internal Revenue Code.

ARCHITECTS, LAND SURVEYORS, PROFESSIONAL ENGINEERS AND STRUCTURAL ENGINEERS

Alvah P. Breitweiser, Fort Meyers, FL - architect license (001-005331) revoked for sealing plans without proper supervision and review and for being disciplined in the state of Florida.
