SPRINGFIELD, IL - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Director of the Division of Professional Regulation, Daniel E. Bluthardt, signed the following disciplinary actions taken during the month of **October 2006**.

ACCOUNTANT

Robert Edward Herrman, Rock Island - public accountant license (065-023195) indefinitely suspended for failure to complete tax and accounting engagement; return records to a client, and for failure to answer a Department inquiry.

John T. Pacholik, Hickory Hills - public accountant license (065-019322) indefinitely suspended for failure to complete tax returns; return records to a client, and failure to respond to a Department inquiry.

ARCHITECTS, LAND SURVEYORS, PROFESSIONAL ENGINEERS AND STRUCTURAL ENGINEERS

John E. Rosenquist, Lake Zurich - structural engineer license (081-005104) fined \$500 and must complete required deficient hours for failure to comply with continuing education requirements.
