SPRINGFIELD, IL - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the following disciplinary actions were taken by the divisions.

Division of Insurance

The Director of the Division of Insurance, Michael T. McRaith, signed the following disciplinary actions during the months of January and February.

Larry Bryan Schweiger, Plantation, FL - insurance producer license revoked effective January 19, 2007. Mr. Schweiger had been licensed since October 2, 1997, to sell life, accident, health, and variable insurance. The license was revoked as a result of an investigation, which revealed that the Licensee has been barred by the NASD from association with any of its members.

Jeffrey A. Conn, Hannibal, MO - insurance producer license revoked effective February 20, 2007. The license of Mr. Conn was revoked by Director's Order from Hearing #06-HR-0984. The hearing was held regarding an Order of Revocation issued by the Division of Insurance dated November 2, 2006. The Order of Revocation was issued as a result of an investigation that revealed Mr. Conn had been convicted in 2005 of Bank Fraud and had failed to report the felony to the Director within 30 days as required by Section 500-95 of the Illinois Insurance Code.

Division of Professional Regulation

The Director of the Division of Professional Regulation, Daniel E. Bluthardt, signed the following disciplinary actions taken during the month of **February 2007**.

AUCTIONEER/ASSOCIATES

Charles Eugene Blagg, Toledo - auction license revoked for a minimum period through August 15, 2011, and fined \$10,000 for having engaged in the practice of auctioneering in violation of a prior disciplinary order.

Knightsbridge Galleries, a Division of D&M Auctioneers, Canoga Park, CA - Knightsbridge Galleries was assessed a \$40,000 civil fine for engaging in the unlicensed practice of auctioneering in Illinois.

David Pickman, Canoga Park, CA - auction license was indefinitely suspended for aiding and abetting the unlicensed practice of Knightsbridge Galleries.
