**Springfield, Illinois** – Aurelia Pucinski, Director of the Illinois Department of Professional Regulation, announced the following disciplinary actions taken by the Department during the month of **October 2002**.

## ACCOUNTANT

**Jefferson D. Haskins Jr., Oak Park** – public accountant license (065-009495) indefinitely suspended for failing to pay Illinois income taxes from 1994 to 1997, 1999 and 2000.

## ARCHITECTS, LAND SURVEYORS, PROFESSIONAL ENGINEERS AND STRUCTURAL ENGINEERS

**Debra Brown, Chicago, and D B Design & Contract Services, Chicago** – Debra Brown ordered to cease and desist the unlicensed practice of architecture, and D B Design and Contract Services ordered to cease and desist from offering architectural services without being registered as a design firm.

**Geoffrey Goldberg, Chicago** – architect license (001-011877) reprimanded and fined \$2,000 for practicing on a non-renewed license.

**Mydoc.com, Indianapolis, IN** – ordered to cease and desist the unlicensed practice of medicine including, but not limited to, treating patients over the Internet and prescribing medication to patients over the Internet without the benefit of performing a physical examination on the patient.
