**Springfield, Illinois** – The Illinois Department of Professional Regulation announced the following disciplinary actions taken during the month of **November 2002**.

**ACCOUNTANT**

**Joel S. Gilbert, Streamwood and Hoffman Estates** – public accountant license (065-019201) indefinitely suspended for failing to respond to a request for information from the Department.

**Robert P. Hanssen, Yorktown Heights, NY** – public accountant license (065-008824) revoked due to criminal conviction in the U.S. District Court for the Eastern District of Virginia of 15 counts of espionage on charges of spying for the Soviet and Russian governments.

**PROFESSIONAL COUNSELORS**

**Michael Ege, DeKalb** – clinical professional counselor license (180-001679) indefinitely suspended for allegedly engaging in deliberate and repeated gestures of a sexual nature with six of his female clients, and allegedly engaging in the sexual exploitation of three of the female clients in that they had disclosed a history of sexual abuse during the course of therapy.

**Brian J. Goodin, Normal** – clinical professional counselor license (180-002163) indefinitely suspended for engaging in a personal and sexual relationship with a former client one month following their three year therapeutic relationship.

**Awanda K. Jones, Westchester** – temporary clinical professional counselor license (179-000268) revoked for representing herself as a licensed clinical professional counselor after her temporary license expired.

**Michael S.
