**Springfield, Illinois** – Robert E. Hewson, Jr., Acting Director of the Illinois Department of Professional Regulation, announced the following disciplinary actions taken by the Department during the month of **January 2003**.

**ACCOUNTANT**

**Horst Roland Rahden, South Barrington** – public accountant license (065-015535) revoked for unprofessional conduct and soliciting professional services by using false or misleading advertising.

**ACUPUNCTURE**

**Yiwu Tang, Evanston** – ordered to cease and desist the unlicensed practice of acupuncture.

**James Koenig Gerstenberg, Skokie** – architect license (001-015481) placed on probation for one year and fined \$1,000 after being convicted of felonies based upon his possession of a controlled substance and having a firearm in the vehicle he had been driving. The Department also alleged Gerstenberg applied his architect seal to a change in architectural plans that were not originally prepared under his direct supervision and control.

**Robert F. Policastro, Chicago** – ordered to cease and desist the unlicensed practice of architecture and structural engineering.

**Kenneth Wentink, Arlington Heights** – ordered to cease and desist using the titles “professional engineer”, “P.E.”, or “engineer,” or any acronym that denotes a title including the term engineer in the state of Illinois.
