**Springfield, Illinois** – Robert E. Hewson, Jr., Acting Director of the Illinois Department of Professional Regulation, announced the following disciplinary actions taken by the Department during the month of **April 2003**.

## ACCOUNTANT

**David E. Lipson, Chicago** – public accountant license (065-007940) ordered to remain in a non-renewed status indefinitely after being found liable for insider trading in the U.S. District Court for the Northern District of Illinois.

**Robert Glen Sedlacek, Chicago** – public accountant license (065-012962) ordered to remain in a non-renewed status indefinitely after the U.S. District Court for the Southern District of New York entered a final judgment against him in a case alleging 15 separate instances of insider trading of securities.

## ARCHITECTS, LAND SURVEYORS, PROFESSIONAL ENGINEERS AND STRUCTURAL ENGINEERS

**Liiban Ahmed Affi, Rockford** – ordered to cease and desist the unlicensed practice of professional and structural engineering and shall not use the title “professional engineer” or “P.E.”

**Anthony Rogers a/k/a Anthony Rodgers d/b/a Lakeshore Development, Chicago** – ordered to cease and desist engaging in the practice of architecture.

**Carlos Santos, Sleepy Hollow, and C.L. Santos & Associates, Ltd., Sleepy Hollow** – Carlos Santos ordered to cease and desist the unlicensed practice of architecture and structural engineering, and C.L. Santos & Associates, Ltd. ordered to cease and desist the unlicensed practice as a professional design firm.

**BARBER, COSMETOLOGY, ESTHETICS AND NAIL TECHNOLOGY**

**Pure Essence Salon, Dolton** – salon license (189-000616) reprimanded and fined \$1,500 for aiding and abetting individuals in the unlicensed practice of barbering, cosmetology, and nail technology.
