ATHLETIC TRAINING

Brian Lee Ball, Lockport – athletic trainer license (096-001867) issued with reprimand and fined \$200 for practicing without a license for approximately nine months.

BARBER, COSMETOLOGY, ESTHETICS AND NAIL TECHNOLOGY

Royan C. Williams, Calumet Park – nail technician teacher license (170-000175) placed in refuse to renew status for being more than 30 days delinquent in the payment of child support.

CONTROLLED SUBSTANCE

Natlsco Division of KRMS, Plantation, FL – controlled substance license (097-000875) reprimanded and fined \$2,500 for practicing on an expired license.

DENTAL

Dominic Boffa, Niles – dentist (019-015987) and controlled substance (319-005629) licenses placed on probation for one year and fined \$2,500 for allegedly prescribing excessive amounts of controlled substances to a patient for purposes which were not therapeutic within the scope of dentistry and failing to recognize or suggest treatment for the patient's drug seeking behavior.
