

CONTINUING EDUCATION FACT SHEET 2008 – REAL ESTATE BROKER RENEWAL

- Do not submit proof of continuing education (CE) with your renewal.

Continuing Education (CE) Hour Requirements

Prior to renewing a license, the licensee shall be required to complete the continuing education between May 1, 2006 and April 30, 2008. (There is no longer a CE exemption for licensees that were “grandfathered”).

- Licensed as a Broker on or before 4/30/2006, **Or** Brokers previously licensed as a Salesperson - **18 hours** of CE is required: 6 hours core /mandatory, 6 hours elective, and 6 hours of the Broker Management Course.
- Licensed as a Broker between 5/1/2006 and 4/30/2007, if NOT previously licensed as a Salesperson, **12 hours** of CE is required: 3 hours core/mandatory, 3 hours elective, and 6 hours of the Broker Management Course.
- Licensed as a Broker on or after 5/1/2007 and not previously licensed as a Salesperson, **6 hours of the Broker Management Course.**

NOTE: Newly licensed Brokers must take the Broker Management Course within 180 days of receiving their license.

Certification of Compliance with Continuing Education Requirements

- 1) Each renewal applicant shall certify, on the renewal application, to full compliance with the CE requirements.
- 2) The Department may require additional evidence demonstrating compliance with the CE requirements. It is the responsibility of each renewal applicant to retain or otherwise produce evidence of such compliance upon request.
