APPROVAL OF MINUTES:

Motion: A motion made/seconded to approve the May 10, 2007 Real Estate Administration and Disciplinary Board Minutes. Motion passed unanimously.

AGENCY UPDATE:

The Division was just informed that as of June 30, 2007, Mary Anne Benden will not be Director of Enforcement because her contract has not been renewed. The Board had a discussion on Ms. Benden's departure and the effect it's going to have with the Division.

The Division currently has 5 real estate investigators.

The ASC audit has been completed with Denise Grave, a representative from ASC, giving a positive verbal response for the Appraisal Division.

The Division continues to get numerous phone calls from salespersons requesting to waive the late fee for their renewal.

Mr. Hardgrove gave an update on the License Bill from last week.

The Chicago Real Estate Staff has officially moved to the Thompson Center on May 9, 2007.

EDUCATIONAL ADVISORY COUNCIL (EAC):

There will be one more training the instructors' seminar for the Broker Management Course early July. EAC approved the following number of applications at the June 14, 2007 meeting:

- 2 pre-license schools
- 24 pre-license courses
- 3 pre-license instructor
- 5 CE instructors
- 2 CE extensions

LICENSING:

The Licensing report reflecting the number of all professional licenses issued within the Real Estate Bureau for May 31, 2007 was distributed. For the month of May, there were 11,782 salesperson's licenses renewed.

A report was given on the passing rate for broker and salesperson's State Examinations through April 2007.

FISCAL REPORT:

Fiscal Reports as of May 31, 2007 were distributed. The report showed the 850 fund having a balance of approximately \$17,500,000.

EXAMINATIONS:

Distributed were three examination reports for the month of May 2007 at the June 14th date but not at today's meeting; they was categorized by "Examinations Completed by Examiner – Licensees with First Examination", "Examinations Completed by Examiner – Compliance Review," and "Examinations –

60 Day Follow-Up” for the month of May. Examinations have conducted 103 audits by using the “Brokerage Verification Report.” Examiners completed 35 examinations with 3 not inspected – as authorized. The compliance review showed 11 offices with 3 offices “referred to supervisor; and the 60 day follow up showed 28 offices with 5 offices “follow-up no longer required.” Examinations Referred to Supervisor – Closed showed 1 exam completed after referral; 3 issues resolved and 1 license status changed.

INVESTIGATIONS:

There is no investigation report to distribute.

PROSECUTIONS:

The Prosecution reports were distributed to the Board. Mr. Hardgrove reported the caseload numbers.

DELIBERATIONS:
