Final Administrative Decision

On May 3, 2024, the Department of Financial and Professional Regulation (“the Department”) issued the below-listed entities a Conditional Adult Use Dispensing Organization License (“Conditional License”) pursuant to the Social Equity Criteria Lottery conducted on July 13, 2023, in accordance with Section 15-35.20(c) of the Cannabis Regulation and Tax Act and 68 IAC 1291.400 through 1291.440 of the administrative rules. This constitutes the Department’s final administrative decision. Each of the below conditional licensees are subject to change as a result of compliance issues pursuant to the Cannabis Regulation and Tax Act and the Department’s administrative rules.

Pursuant to Section 15-175(a) of the Cannabis Regulation and Tax Act, this final administrative decision is subject to judicial review under the Administrative Review Law, 735 ILCS 5/3-101 *et seq.* Accordingly, applicants have 35 days from the May 3, 2024 issuance of this final administrative decision, or until June 7, 2024 to file any claims for judicial review.
