IDFPR Disciplinary Actions for January 2008

SPRINGFIELD - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Directors of the Division of Professional Regulation, Daniel E. Bluthardt, and Insurance, Michael T. McRaith, signed the following disciplinary orders in January. Orders for the Division of Banking were authorized by Director Jorge Solis.

Division of Insurance

Marlon B. Gilbert, Waukegan – insurance license to sell life, accident, and health insurance denied effective January 8, 2008 by Director's Order from Hearing #07-HR-0866. The hearing was held regarding the Department's Letter of Denial dated August 1, 2007. The Letter of Denial was issued as a result of an investigation revealing Mr. Gilbert had been convicted of felony Home Invasion in 1998.

Menachem Yossinger, Arlington Heights – insurance producer license to sell life, accident, health, fire and casualty insurance revoked effective January 8, 2008. Mr. Yossinger had been licensed since 1982. The license of Mr. Yossinger was revoked by Director's Order from Hearing #07-HR-0724. Additionally, the Director's Order required Mr. Yossinger to pay a \$10,000 civil forfeiture and \$266 in hearing costs all within 35 days of the entry date of the Order. The hearing was held regarding the Department's Order of Revocation dated June 11, 2007. The Order of Revocation was issued as a result of an investigation revealing Mr. Yossinger had requested loan checks from an insurer without the consumer's permission or authorization and obtained the loan proceeds totaling \$21,000. Mr. Yossinger, when questioned, only repaid \$18,000 of the \$21,000.

Mark A. Mendenhall, Mt. Vernon – insurance producer license to sell life, accident and health insurance revoked effective January 10, 2008. Mr. Mendenhall had been licensed since June 21, 2000. The license of Mr. Mendenhall was revoked by Director's Order from Hearing #07-HR-0829. Additionally, the Director's Order required Mr. Mendenhall to pay a \$5,000 civil forfeiture and \$691 in hearing costs all within 35 days of the entry date of the Order. The hearing was held regarding the Department's Order of Revocation dated September 7, 2006. The Order of Revocation was issued as a result of an investigation revealing Mr. Mendenhall had violated insurance laws of another state, had his license revoked in that same state (Kentucky) and failed to reveal such action to the Division.

William D. Zahalka, Chicago – insurance license to sell life, accident and health insurance denied effective January 10, 2008. The license of Mr. Zahalka was denied by Director’s Order from Hearing #07-HR-1078. The hearing was held regarding the Department’s Letter of Denial dated August 21, 2007. The Letter of Denial was issued as a result of an investigation revealing Mr. Zahalka had been convicted of felony Possession of a Controlled Substance in 2005. Additionally, the Director’s Order required Mr. Zahalka to pay hearing costs and a civil forfeiture in the amount of \$1,000.

Judd D. Campbell, Chicago – insurance producer license to sell life, accident and health insurance revoked effective January 17, 2008. Mr. Campbell had been licensed since August 4, 2006. The licenses were revoked as a result of an investigation, which revealed that the Licensee violated a Stipulation and Consent Order by failing to pay the civil forfeiture of \$1,000 within 30 days as required by the Order.

Anthony L. Black, Springfield – insurance producer license to sell life, accident, health, property and casualty insurance revoked effective January 28, 2008. Mr. Black had been licensed since March 21, 1996. His license application was denied as result of an investigation, which revealed that the Licensee improperly withheld \$4,573.18 of premiums from an insurer and he failed to facilitate and aid the Director in an examination.

Albert W. Pettibone, Jr., Hannibal – insurance producer license application to sell life, accident, health and variable insurance denied effective January 28, 2008. His license application was denied as a result of an investigation, which revealed that the Applicant was convicted of felony Driving With Excessive Blood Alcohol Content on August 1, 2006.

Kemmie L. Weatherspoon, Fort Dodge, Iowa – insurance producer license application to sell limited lines insurance denied effective January 28, 2008. Her application was denied as a result of an investigation, which revealed that the Applicant was convicted of felony Theft in the Second Degree on January 21, 2005.
