IDFPR Discipline Report for March 2008

SPRINGFIELD - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Directors of the Division of Professional Regulation, Daniel E. Bluthardt, Division of Financial Institutions, Robert Meza, and Division of Insurance, Michael T. McRaith, signed the following disciplinary orders in March. Orders for the Division of Banking were authorized by Director Jorge Solis.

Banks

PAWNBROKER

Trader Jon's, Round Lake Beach – ordered to cease and desist and levied a civil penalty of \$750, for practicing as a pawnbroker without a license.

Crest Hill Pawn and Jewelry, Crest Hill – ordered to cease and desist and levied a civil penalty of \$750 for practicing as a pawnbroker without a license.

RESIDENTIAL MORTGAGE

Solutions Funding, Inc., Itasca – residential mortgage license (MB.0004223) revoked for failure to notify Department of change of address, and failure to maintain loan files.

Alamo Mortgage Service, Chesterton, IN – residential mortgage license (MB.0006248) revoked for improper surrender of license, failure to make documents available for examination, and failure to pay an examination fee.
