Division of Insurance

Joshua Pondexter, Matteson – insurance producer license revoked effective July 6, 2007. Mr. Pondexter had been licensed since October 31, 2000. Mr. Pondexter was licensed to sell life and variable insurance. The license was revoked as a result of an investigation, which revealed that the licensee failed to abide by and violated a Stipulation and Consent Order by failing to pay the civil forfeiture of \$2,000 within 30 days as required by the Order.

John C. Wils, East Moline – insurance producer license revoked effective July 20, 2007. Mr. Wils had been licensed since July 28, 1986. Mr. Wils was licensed to sell life, accident, health, fire, casualty, and variable insurance. The license of Mr. Wils was revoked by Director’s Order from Hearing #06-HR-0681. Additionally, the Director’s Order required Mr. Wils to pay: a \$16,000 civil forfeiture, \$13,129.49 in restitution to an insurer, and \$371 in hearing costs all within 35 days of the entry date of the Order. The hearing was held regarding the Department’s Order of Revocation dated August 15, 2006. The Order of Revocation was issued as a result of an investigation revealing Mr. Wils had improperly withheld \$8,129.49 in premiums from an insurer; changed an insured’s address to his own with out the consumers knowledge; submitted a loan request for \$5,000 on behalf of the insured with out their knowledge, forged the consumers signature; and deposited the \$5,000 in his personal bank account.
