Brickyard Bank, Lincolnwood – consent order to stop engaging in unsafe and unsound banking practices.

Broadway Bank, Chicago – Division of Banking took possession and control of bank on April 23, 2010 for the purpose of receivership.

CONSUMER CREDIT

A Plus Title Loans, Inc., 229 South Arlington Heights Road, Arlington Heights – CILA License (3270) fined \$3,500 for the following violations: The loan document or other legal instrument contained blanks, title-secured loan was not fully amortized or was not repayable in substantially equal installments, title-secured lender did not obtain borrower's most recent income documentation available at the time the loan was made, repossession file did not indicate a statement of final accounting containing the required information was sent to the borrower, repossession file did not contain a copy of the condition of collateral at the time of repossession, lender did not obtain any official documentation of the borrower's income before making a payday or title-secured loan, file did not contain evidence of a Wage Assignment signed by the wage earner, and security was not released.

Advance Paycheck, Inc., 17157 South Harlem Avenue, Tinley Park – CILA License (3485) fined \$5,225 for the following violations: Original documents or approved equivalent, not cancelled or returned following payoff, and licensee's or retail seller's name and address was not properly disclosed on legal document.

Check Into Cash of Illinois, LLC, North Prospect Plaza, 1507 North Prospect Avenue, Champaign – CILA License (1294) fined \$2,125 for the following violations: The licensed location does not maintain a file of original papers and file did not contain evidence of a contract signed or acknowledged by the borrower.

Cottonwood Financial Illinois, LLC, 745 West Howard Street, Pontiac – PL License (1605) fined \$1,000 for failure to input accurate information into the database to determine if the obligor was eligible for a loan.

Cottonwood Financial Illinois, LLC, 745 West Howard Street, Pontiac – CILA License (3366) Fined \$9,000 for the following violations: Improper simple interest calculations, licensee did not deliver or mail to the borrower an affidavit of defense, repossession file did not indicate a statement of final accounting containing the required information was sent to the borrower, and security was not released.

Cottonwood Financial Illinois, LLC, 1005 North West Street, Suite B, Olney – CILA License (3391) fined \$3,000 for improper simple interest calculations.

Cottonwood Financial Illinois, LLC, 401 East Walnut Street, Carbondale – CILA License (3355) fined \$8,200 for the following violations: Improper simple interest calculations, licensee did not deliver or mail to the borrower an affidavit of defense, repossession file did not indicate a statement of final accounting containing the required information was sent to the borrower, repossession file did not contain a copy of the condition of collateral at time of

repossession, and lender did not input accurate information into the database to determine if the obligor was eligible for a loan.

Cottonwood Financial Illinois, LLC, 142 Dettro Drive, Mattoon – CILA License (3357) fined \$1,525 for the following violations: Improper simple interest calculations, make, model, year, and VIN of automobile were not on the title-secured loan document, and title-secured lender did not obtain borrower's most recent income documentation available at the time the loan was made.

Cottonwood Financial Illinois, 301 West Lincoln Avenue, Unit B, Charleston – CILA License (3370) fined \$6,150 for the following violations: Improper simple interest calculations, title-secured lender did not obtain borrower's most recent income documentation available at the time the loan was made, and lender did not input accurate information into the database to determine if the obligor was eligible for a loan.

Cottonwood Financial Illinois, LLC, 357 West Stevenson Road, Ottawa – CILA License (3381) fined \$4,800 for the following violations: Improper simple interest calculations, lender made a title-secured loan with a scheduled monthly payment exceeding 50% of the obligor's gross monthly income, title-secured lender did not obtain borrower's most recent income documentation available at the time the loan was made, and licensee did not deliver or mail to the borrower an affidavit of defense.

Cottonwood Financial Illinois, LLC, 300 West Broadway, Suite E, Mount Vernon – CILA License (3385) fined \$1,000 for improper simple interest calculations.

Cottonwood Financial Illinois, LLC, 281 East US Route 6, Unit 10, Morris – CILA License (3379) fined \$2,200 for the following violations: The loan document or other legal instrument contained blanks, the licensed location did not properly maintain individual account records or transaction histories, and lender did not input accurate information into the database to determine if the obligor was eligible for a loan.

Cottonwood Financial Illinois, LLC, 4221 East State Street, Rockford – PL License (1586) fined \$1,000 for failure to obtain any official documentation of the borrower's income before making a payday or title-secured loan.

Get It Now, LLC, 1511 North Lewis Avenue, Waukegan – SF (1286) fined \$2,750 for the following violations: The annual percentage rate is not accurately disclosed, the loan document or other legal instrument contains blanks, improper simple interest calculations, and file did not contain evidence of a contract signed or acknowledged by the borrower.

Great Lakes Specialty Finance, Inc., 18226 South Kedzie, Hazel Crest – PL License (1133) fined \$4,150 for the following violations: The loan document or other legal instrument contained blanks, lender did not input accurate information into the database to determine if the obligor was eligible for a loan, and lender did not obtain any official documentation of the borrower's income before making a payday or title-secured loan.

Illinois Lending Corporation, 100 West Randolph Street, Chicago – PL License (1638) fined \$1,000 for charging more than \$15.50 per \$100 loaned on a payday loan.

Short Term Loans, LLC, 376 South Route 59, Suite 132, Naperville – PL License (1648) fined \$1,150 for the following violations: The loan document or other legal instrument

contains blanks and lender made a payday loan resulting in the borrower having combined outstanding payday loan principal balances greater than 25% of borrower's gross monthly income.

The Payday Loan Store of Illinois, Inc, 2150 West Galena Boulevard, Aurora – PL License (1659) fined \$2,000 for the following violations: the payment receipt did not accurately show the required elements, lender did not input accurate information into the database to determine if the obligor was eligible for a loan, and official income documentation was not the required type for a payday loan or was not for income for the 30 days preceding the loan.

The Payday loan Store of Illinois, Inc., 2904 Ogden Avenue, Aurora – PL License (1558) fined \$7,350 for the following violations: Licensee did not properly maintain loan records for two years after final entry, lender made or purchased loans without the required license, lender did not enter into the database that the borrower's loan was paid in full or cancelled on the day the transaction was made, and loans over 25% of borrower's gross monthly income.

The Payday Loan Store of Illinois, Inc., 7001-A North Clark Street, Chicago – PL License (1305) fined \$2,000 for the following violations: Lender did not input accurate information into the database to determine if the obligor was eligible for a loan, and lender made a payday loan resulting in the borrower having combined outstanding payday loan principal balances greater than 25% of borrower's gross monthly income.

The Payday Loan Store of Illinois, Inc., 2904 Ogden Avenue, Aurora – CILA License (3343) fined \$13,100 for the following violations: Recording fee or closing cost is collected but not paid, improper simple interest calculations, licensee did not disclose on delinquency notices for title-secured loans the availability of debt management information at DFI's toll-free number, the title-secured loan agreement did not prominently disclose DFI's address and phone number and advise the borrower of the right to report lending and collection violations, the lender did not provide the borrower with written verification of the cash proceeds of the loan on a title-secured loan or payday loan, and title-secured lender did not obtain borrower's most recent income documentation available at the time the loan was made.

Title Lenders, Inc., 815 Lincoln Highway, Suite 107, Fairview Heights – CILA License (2156) fined \$1,000 for failure to input accurate information into the database to determine if the obligor was eligible for a loan.

Turnage Group, Inc., 10251 South Wabash Avenue, Chicago – CILA License (3415) fined \$1,500 for the following violations: The loan document or other legal instrument contained blanks and security was not properly disclosed.

U.S. Cash Advance Illinois, LLC, 1642 West 79th Street, Unit C, Chicago – CILA License (3294) fined \$3,575 for the following violations: The annual percentage rate was not accurately disclosed, the file or original papers for the loan was not properly maintained, improper simple interest calculations, licensee was compounding interest or collecting interest in advance, security was not properly disclosed, lender was charging improper, excessive, or undisclosed late payment fees, evidence of a signed or acknowledged Truth-In Lending Disclosure was not in the file of original papers, the loan contract did not accurately disclose the schedule of payments or the total of payments, and annual percentage rate and finance charge in the Truth-In Lending disclosure were not more conspicuous than the other items in the disclosure.
